APPROVAL OF MINUTES

Marcia moved that the minutes from the February 26 meeting be approved as written; Jennifer seconded. Minutes were approved.

OLD BUSINESS

- Policy Review Work Group Tom reported that progress is being made on the overarching safety policy for the university; it is anticipated that it will be reviewed by the policy committee soon.
- Safety Walks Due to the COVID-19 outbreak, the two remaining safety walks for 2019 will be placed on hold.

REVIEW OF ACCIDENT REPORTS

Heidi does not anticipate many claims for COVID-19 illness due to exposure at work. Katie Vorderstrasse in Risk will take the lead on any claims.

FIRE SAFETY INSPECTIONS UPDATE

Reports and inspection schedules are posted on the EH&S website.

Jim noted that the new inspection form is not working very well yet. His group is waiting for better reports prior to disseminating information to campus. They are getting more information on violations and the associated corrective actions.

FACILITIES MONTHLY LIFE/SAFETY WORK ORDERS

- Blue lights at the parking structure, Legacy Park, 14th and 26th Streets were repaired
- Adams Hall had a natural gas smell
- Johnson Hall had a beeping sound coming from the ceiling; cleared

A burning smell in Kerr originated with workers in the basement

EH&S ON-CALL LOG/REPORT OF UNSAFE CONDITIONS

- Indoor air quality issues
- Mold at CEOAS Administration building
- A gas alarm (on a Sunday) at Johnson Hall indicated failure of the exhaust system. Another shutdown of the system occurred on Friday. There are alarm system problems that need to be addressed.

NEW BUSINESS

- EH&S and Risk are looking at information from incident reports; will share with the UHSC within the next quarter.
- Heidi and Mike B are pulling information from SAIF incident reports to summarize the data, but work is currently postponed due to the coronavirus.

COVID-19

A plan is being developed for lab work. General requirements include:

- One person in a lab at one time, unless it would be dangerous for the person to work alone
- All workers need to follow basic safety procedures when working alone in labs
- No new experiments may be started, especially any involving animals or human subjects
- Lab managers will do prep work
- Critical lab workers need to be better defined

The Research Office has put out some guidance; more is expected regarding building closures.

Additional discussion:

- Each college seems to be handling things differently.
- Building Managers should be directing building cleanings.
- Jon-Michael wants a holistic response regarding locking and unlocking buildings.
- Any special requests regarding building wipe-downs should be routed to Joe Majeski in Facilities Services who will coordinate with ABM Custodial services.
- The Library procured an extra contract to do extra cleaning.
- A plan for building lock-downs is due to be delivered tomorrow.
- Students have one more week to move out of dorms and get a refund for the term
- Students are not being asked to leave the dorms
- Scams are already being perpetrated, so beware
- Insurance coverage for workers who get COVID while traveling will depend on where they
 are and whether they are traveling for business or pleasure
- There has been a mandatory recall of all OSU worldwide travelers as of March 12
- The recall included 102 students and 50 staff/faculty
- Some exceptions to the travel recall have been allowed
