3. Recent and Ongoing Business

3.1 Safety Walks (2020 Report and 2021 Assignments)

4. Accident & Inspection Reports

4.1 Accident Reports

It was noted that there have not been too many laboratory incidents, which is good. Information is tracked by department, not location.

The committee discussed whether working from home is adding to/lowering the accident rate. Heidi reported that there have only been a few ergonomic issues. Departments are encouraged to prevent injuries with pre-planning and proper equipment. Trips and falls are fairly common. Accidents while working from home are a little trickier. Employers should have the right to review workspaces to be sure their workers are safe. Workers need to identify and address hazards. Some employers have home visit protocols in place.

4.2 Fire Safety Inspections

There was an article in OSU Today on winter home safety. Most campus buildings are pretty quiet right now. Fire and Life Safety is conducting business as usual; inspections are being done on schedule. No incidents have occurred. Jim is working on some new policies for hot work and fire drills. Drills will not be instated until building occupancies are back to normal.

7. Agenda Item(s) for Next Meeting

Hoping to soon have restricted access to the facility. They are also providing some spaces for athletic teams to practice. Staff are offering consultations regarding infection control planning for various activities, which EHS also does.

The committee briefly talked about how the food delivery robots will behave when students return to campus and there are more obstacles.
