APPROVAL OF MINUTES:

The minutes from May were approved, pending update of safety training data.

REVIEW OF ACCIDENT REPORTS

The slip that occurred in McNary Dining was on a mat; no apparent cause was found.

A person who works for Rec Sports was injured while volunteering at the time (doing the same work as they are paid to do). Workers sometimes volunteer in order to get more experience. This is a voluntary opportunity for workers, not an expected duty. Rec Sports is reviewing their policies.

An incident involving use of a lift gate did or will require updated training for using the lift gate.

There was a hydrofluoric acid spill which involved one person being splashed on their hand. Response by all involved was very good. Calcium gluconate was used to initially treat the splash, then they were taken to the hospital for follow up. An open waste container was bumped, causing the spill. Additional training will be provided regarding waste containers, volumes, etc. OSU should implement a hydrofluoric acid policy/program similar to what has been established for pyrophorics.

EH&S REPORT OF UNSAFE CONDITIONS

No items of interest/concern were reported.

FACILITIES MONTHLY LIFE-SAFETY WORK ORDERS REPORT

A biosafety lab's fume hood is not working; no response has been received.

Drivers have been noted turning the wrong way onto 26th Street from Monroe. Mike M will contact Nathan Patterson in Construction/Maintenance to see about additional signage.

Orchard Street near Cordley – cars are speeding and a crosswalk (and possible removal of parking space for visibility) is needed near the A1 parking lot.

The road between CH2M and the parking structure – people are not stopping at sign. Painting lines might help.

SAFETY TRAINING UPDATE

Mike noted that SAIF is offering Train the Trainer sessions for Sim-plicity (a condensed version of all four SIM modules) on July 23, and SIM Train the Trainer on August 12-13.
