

# OSU Chemical Safety Committee

## Committee Charge and Purpose

The Chemical Safety Committee (CSC) focuses on chemical safety issues relating to OSU campuses and off-campus research and instructional activities and its members are charged with the following key responsibilities:

- Review of protocols for high hazardous chemical use or other chemicals that may necessitate Committee review due to unique or special hazards to include:
  - Identify that unreasonable risks to personnel, property or the environment do not exist;
  - verify the adequacy of technical procedures to minimize occupational exposures;
  - review the qualifications of the applicants undertaking the proposed research and make recommendations, if appropriate;
  - approve, recommend change to, or deny the intended use of the chemical as proposed in the OSU Chemical Hygiene Plan (CHP).
- Provide guidance on chemical safety training resources for staff and students.
- Annual review and approval of substantive changes to the CHP.
- Provide review and feedback of EH&S proposed chemical management resources, procedures, or technologies.
- Review of chemical safety assessment statistics and trend data as generated by EH&S.
- Coordinate with other OSU research oversight committees as requested for studies involving hazardous or cytotoxic chemicals.
- Consideration for review of chemical-related hazards not covered by the other campus research oversight committees.
